Their most recent class Q application was refused. Fernfield Homes seek to work closely with the community and obtain full planning permission to develop ten homes across the two sites.

Mr Cartridge raised the potential of including provision of support to Kenardington within the new application. Cllr McIntyre said that any support would be considered provided it was proportionate, it met the needs of the local residents and was clearly articulated as part of the formal planning process.

Mr Simon Honner said he felt very welcome in the meeting and enjoyed the discussion on planning an area he is particularly interested in.
